

Subject: Website Information Notice (ART. 13 D.Lgs. 196/2003).

This page describes how to manage the website with regard to the processing of personal data of the users who consult it.

This is the information notice made pursuant to art.13 of Legislative Decree no. 196/2003 - Code on the protection of personal data to those who interact with the company's web services, accessible by online address starting from:

corresponding to the homepage of the official website.

The information notice is made for this site only and not for any other websites that may be consulted by the user through links.

The information notice is also inspired by Recommendation no. 2/2001 that the European personal data protection authorities, united in the Group established by Art. 29 of Directive No. 95/46 / EC, adopted on 17 May 2001 to identify certain minimum requirements for the collection of online personal data, and in particular the modalities, times and nature of the information that Data Controllers should provide to the users when they connect to web pages, regardless of the purpose of the link.

THE DATA CONTROLLER

Following the consultation of this site, data relating to identified or identifiable persons can be processed.

PLACE OF DATA PROCESSING

Data treatments linked to web-services of this site *take place* at the aforementioned premise and are handled only by technical staff of the Office responsible for processing, or by occasional operators assigned to maintenance processes.

No data deriving from the web service is communicated or diffused.

Personal data provided by users submitting requests for information (bulletins, CD-ROMs, catalogs, lists, answers to questions, various acts, etc.) are used for the sole purpose of performing the required service or performance.

TYPES OF TREATED DATA

Navigation data

The computer systems and software procedures for the operation of this website acquire, during their regular process, some personal data whose transmission is implied in the use of Internet communication protocols.

These information are not collected in order to be associated with identified stakeholders but which, by their very nature, could, allow users to identify themselves through elaborations and associations with data held by third parties.

This category of data includes the IP addresses or domain names of computers used by users who connect to the site, the URI notation addresses (Uniform Resource Identifier) of the required resources, the time of the request, the method used to submit the request to the server, the file size obtained in response, the numeric code indicating the status of the response given by the server (good end, error, etc.) and other parameters related to the operating system and the user's computer environment.

This data is used only for the purpose of obtaining anonymous statistical information on the use of the site and to check its correctness operation and are deleted after 1 year.

Data may be used for the detection of responsibility in the event of hypothetical cybercrime to damage the site.

Data provided voluntarily by the user

The optional, explicit and voluntary sending of e-mail to the addresses indicated on this site involves the subsequent acquisition of the address of the sender, which is necessary to answer to the requests as well as any other personal data included in the letter. Synthesis Information Specifications will be progressively reported or displayed on the site pages provided for particular services on request.

COOKIES

No personal data of users is acquired by the site. No cookies are used for broadcasting personal information, neither any kind of so-called "Persistent cookies", i.e. users tracking systems.

The use of so-called "Session cookies" (which are not permanently stored on the user's computer and vanish with the browser closure) is strictly limited to the transmission of session identifiers (consisting of random numbers generated by the Server) needed to allow safe and efficient site browsing.

The so-called "Session cookies" used on this site avoid the use of other potentially damaging IT techniques for the privacy of user browsing and do not allow the acquisition of personal identification data of the user.

OPTIONAL DATA CONFIRMATION

Aside from what is specified for navigation data, the user is free to provide personal data. Their non-delivery may of course result in the impossibility of obtaining what is required.

TREATMENT METHOD

Personal data are handled both with electronic and automated tools, as well as on paper, for the time strictly necessary to achieve the purposes for which they were collected.

Specific security measures are being taken to prevent data loss, misuse or incorrect use and non-authorized accesses.

DATA SUBJECT'S RIGHTS

The subjects to which the personal data are referenced have the right at any time and for free to obtain confirmation of the existence or not of the same data and to know its content and origin, to verify its accuracy or to ask for its integration or updating or rectification and blocking (see Art. 7 of Legislative Decree 196/2003 to be read in full).

Under the same art. 7 you have the right to request the cancellation, transformation into anonymous form or the total block of the data processed in violation of the law, as well as to oppose in any case, for legitimate reasons, their treatment.
